# **Carbon County 4-H Council Funding Request Policy**

#### **Requirements:**

- 1. Complete application
- 2. Must turn in information about the event
- 3. Must have been a 4-H member for at least 2 years
- 4. Must be a 4-H sponsored or related event

## **Individual applicants:**

If all requirements have been met and the 4-H Council deems the application worthy of funding, the following formula shall be used to determine the amount granted:

75% of the estimated out of pocket expenses with a maximum of \$500.00 per individual per event.

After approval, the recipient will be sent 80% of funds immediately and the remaining 20% shall be paid after the recipient completes 2 of the 3 following activities:

- 1. Presentation about event to the 4-H Council. (mandatory)
- 2. Presentation about event to their club or other clubs.
- 3. Display or Presentation at the Carbon County Fair.

To receive the remaining 20% the individual must complete and submit a completion report (written explanation of the activities completed) to the 4-H Council. \* The report must be completed and submitted to the Council by the end of the 4-H year (September 30).

#### **Team event applicants:**

Each team member must complete individual applications. If all requirements have been met and the 4-H Council deems the application worthy of funds, the following formula shall be used to determine the amount granted:

50% of the estimated out of pocket expenses with a maximum of \$300.00 per individual per event. The maximum amount the Council will pay out per team event (regardless of the number of members) is \$2500.00.

After approval, the recipient(s) will be sent 80% of funds immediately and the remaining 20% shall be paid after the recipient(s) completes 2 of the 3 following activities:

- 1. Presentation about event to the 4-H Council. (mandatory)
- 2. Presentation about event to their club or other clubs.
- 3. Display or Presentation at the Carbon County Fair.

To receive the remaining 20% the individual must complete and submit a completion report (written explanation of the activities completed) to the 4-H Council. \*These activities must be completed and submitted to the Council by the end of the 4-H year (September 30).

The 4-H Council reserves the right to grant funds exceeding these guidelines at their discretion.
