From a judge perspective hard to have eye contact and clear communication. National states no hat in the youth show ethics. Hat has provided confidence. Emma Carlson commented to have as recommended versus requirement. Presents safety concern. Statement in rule book recommending not wearing hats. Valery suggested making them aware of national requirement but not requiring it in our program. Dennis asked about the Code of show ring ethics, national document. Jim suggested to document within our rule books, policies to maintain consistency whichever direction we go. Put the responsibility on parents and leadership to help maintain this control.
