

Teen Leadership Camp – June 24-June 26, 2017

Where:

Teen Leadership Camp is being held at Careless Creek Getaway north of Shawmut.

The physical address is 994 Hwy 297 North, Shawmut, MT.

Driving Directions:

From Shawmut, MT, take MT Highway 297 (just on the west side of town) going north 9 miles to road T. Turn right, go east 0.5 mile. Turn left, go north 0.5 mile. Careless Creek Ranch Getaway lodge is on the left, nestled in the cottonwood trees along Careless Creek.

When:

Our adventure will begin at 10:00am on Saturday June 24 and will conclude at 3:00pm on Monday June 26, 2017.

What to pack:

We will be staying in large tents at the Careless Creek Getaway Guest Ranch. There are showers and bathrooms at the facility. You will need to pack:

- Sleeping bag, pillow, air mattress. Please do not bring large air mattresses because we may not have room for them and they could get damaged.
- Towel and toiletries
- Several changes of clothes for warm and cool temperatures (We will be outdoors most of the time so you should plan for all types of weather, even rain)
- Sun screen
- Appropriate clothing for optional water balloon fight
- Good walking shoes
- Flash light

Other information:

We will be providing meals, snacks and drinks, so you do not need to bring any food or drinks with you. If you have any food sensitivities or allergies please contact us right away.

There is very limited cell service at the camp location, so you may not want to bring your phone. If you do, we ask that you do not use it during any of our activities.

Everything you will need for the activities and the workshops will be provided for you, so you don't need to worry about any supplies.
